*MEMBERSHIP – Bob Cooley - We have 198 members, 130 Indiv, 33 Family memberships.

*PR – Peter Indorf – No Report - John asked that we update the bio on the BCA website. Richard mentioned that we need to mention the programs more often in the email communications since our programs are really the heart of the club.

*COMPETITIONS – Nancy Williamson – No Report – John questioned having members vote on competitions 4 times a year. All agreed in 2019 we will not have members vote on competitions each quarter. George will need to change the rules on the website in 2019.

*WEBMASTER – George Campbell – webpage is currently broken. He is working on it.

*NEWSLETTER – John – Newsletter will be published on the 25th of every month. John will not be doing the newsletter next year. We will need to find someone else to edit the newsletter.

OLD BUSINESS

- * John and Peter will be looking for opportunities to mentor students at the Brevard School Foundation. Volunteers will be solicited when opportunities exist.
- *Capture Florida John asked when we start the competition. Suggesting was made that we do not dictate a start date. April or May 2019 would be the end month for the competition. Need to hand out assignments per the signup lists previously

established. Richard made a proposal for different committees, submitting them to John. Rob suggested we have volunteers sign up for committees established. After some discussion, it was decided that the core committee will meet to establish the sub committees – The core committee consists of Ann, Nancy, Richard, George, and John. John will call a separate core committee meeting at his house.

- Notes from previous meetings for reference Still thinking about a state-wide camera club event, but we did decide we would change our annual Capture Brevard to a Capture Florida event within the CCB only in 2019. Richard has talked to FCCC and Glennie regarding software/website infrastructure. Glennie uses File Maker Pro to establish the file management system. FCCC will allow us to use their mailing list for publicity. The FCCC has no problem with our club organizing and sponsoring a state-wide event. Richard suggested there could be 15 committees involved in the event. 35 people expressed an interest in helping at the last meeting. We will see how our own club first event works next year before taking it state-wide. * We had some discussion as to what the committee assignments may be. We plan to dry-run the state-wide competition within the CCB in 2019. Therefore, the CCB 2019 Capture Florida will be a competition. We believe there would be no time limit as to when the photo was taken, and we will have to select categories that favor a diverse selection of Florida photos.
- * eMail list 2018 The 2018 email list was updated. Ann will carefully delete the lists not needed.
- * Use Policy for CCB email distribution list Chuck made a motion (in the previous Board Meeting) to limit the use of the CCB email list to CCB sponsored business only. The motion suggested that our CCB email list would only be used for communication of CCB activities. Any personal photography related want ads would not be in any email communication from the CCB. Therefore, appropriate related want-ads would only be included as a brief two-line entry in the newsletter under a separate heading at the end of the newsletter. Richard seconded the motion. In this meeting, there was some discussion. Peter supported the change in policy due to the logistics involved. Richard pointed out that we should still mention our sponsors in the appropriate emails when gifts or services are provided for one or more CCB events or functions. All agreed we should continue to thank our sponsors where appropriate. The motion was carried by unanimous vote.
- *Guest Protocol Bylaws Although we decided not to pursue a guest policy in our bylaws at our last meeting, John suggested there are people taking advantage of members by participating without being a member. He stated that Lib and Hermann have drafted a bylaw change and will provide a proposal at a future meeting. Discussion suggested that it is difficult to determine who are not members during the normal meetings. Several people suggested we do not want to initiate a sign in procedure at meetings. No decision made as to how to proceed.

However, after further discussion, we decided that the logistics to mark the mats are too cumbersome. Therefore, we decided not to implement this idea.
